Privacy Policy

TunTrust uses its best endeavors to respect your privacy while you visit this website and understands just how important this is to you. To this end, we do our utmost to respect your privacy in connection with your use of this website.

The terms "TunTrust" or "we" or "our" or "us" refer to TunTrust, the entity acting as data controller in relation to the processing of your information on this website.

We shall take all necessary measures to ensure that the personal data we hold about you is processed correctly and lawfully. We shall also take all necessary steps to implement and comply with this Privacy Policy.

Collection and use of personal data:

We collect your personal data when you interact with us during the certificate application. Customers provide to TunTrust the following information about Individuals: your name, email address, phone number, address and any other personal data reasonably related to the conduct of TunTrust's services.

Where Customers share personal information of Individuals with TunTrust, Customers represent that they have collected and processed such information in accordance with data protection laws, and that they have duly informed the Individuals that their personal information was provided to TunTrust. TunTrust will process such information following Customer instructions, as strictly necessary to provide the services contracted by Customer.

Processing purposes:

We will process your personal data on the basis of one or more of the following:

- the processing is necessary for the performance of a contract or for entering into a contract with you (e.g. by delivering you the ordered product or service);
- the processing is necessary for us to comply with a legal or regulatory obligation;
- the processing is necessary for our or a third party's legitimate interests, for example:
 - when answering and managing any query from you;
 - providing you with the product, service or information requested; -sending you marketing email;

- improving the quality of our services and our website and generally managing our relationship with our customers;
- we may also combine the personal data collected with our data on your use of other TunTrust services in order to make you offers which better suit your requirements.

Data disclosure:

The personal data we collect shall not, in any circumstance, be passed on to third parties without your knowledge and/or consent (when such consent is legally required). To achieve the purposes described above, we may share with our subcontractors, with our service providers which support us technically in the provision of our services, with public administrations and related bodies to the extent necessary for us to comply with any applicable laws and regulations.

All of our employees and sub-contractors who have access to your personal data are obliged to keep it confidential and secure. They shall have access only to the data they require in order to perform their tasks or obligations, unless otherwise provided by laws or regulations.

Your rights:

You have the following rights in relation to the processing of your personal data (subject to applicable requirements and exemptions):

- right to access the personal data held about you and receive additional information about how it is processed;
- right to rectify any inaccurate and incomplete personal data;
- right to delete your personal data from our systems in certain circumstances, e.g. where the personal data is no longer necessary in relation to the specified purposes;
- right to restrict the processing of your personal data in certain circumstances, e.g. where you contest its accuracy or object to processing;
- right to receive your personal data in an interoperable format, or have it directly transmitted to another organization;
- right to withdraw your consent at any time where the processing is based on your consent to the processing of personal data;
- right to object to the processing of your personal data, in certain circumstances and considering other regulatory requirements, in particular where we rely on legitimate interests; and
- right to lodge a complaint with the Tunisia Data Protection Authority (Instance Nationale de Protection des Données Personnelles).
